## OCEANO COMMUNITY SERVICES DISTRICT, STATE OF CALIFORNIA A RESOLUTION CLOSING DISTRICT OFFICES ON NOVEMBER 28, 2014, DECEMBER 26, 2014 and JANUARY 2, 2015

The following resolution is now offered and read:

**WHEREAS**, the Oceano Community Services District (hereinafter referred to as "District") operates a community water system, a community wastewater system, and provides other services for the community; and

**WHEREAS,** the District does not recognize November 28, 2014, December 26, 2014 or January 2, 2015 as holidays; and,

WHEREAS, November 28, 2014, December 26, 2014 and January 2, 2015 are all on Fridays and are the days after Thanksgiving, Christmas and New Year's Day, which are recognized holidays; and

WHEREAS, District employees have requested that the District close for normal operations, including closure of the office, on November 28, 2014, December 26, 2014 and January 2, 2015; and,

WHEREAS, no significant need exists for the District to be open for normal operating purposes on November 28, 2014, December 26, 2014 and January 2, 2015 because they are the day after holidays which traditionally have little operating or customer activities, especially on Fridays; and

WHEREAS, closing the District for normal operations, including closure of the office, on November 28, 2014, December 26, 2014 and January 2, 2015 will provide cost savings to the District by reducing labor costs, utility costs, and other costs that would be normally incurred because closing the District will result in the need for District employees to take vacation time, paid time off other than sick leave, and/or leave without pay; and

WHEREAS, closing the District on November 28, 2014, December 26, 2014 and January 2, 2015 will provide cost savings to the District by reducing labor costs, utility costs, and other costs that would be normally incurred because District employees will need to take vacation time, paid time off other than sick leave and/or leave without pay; and

WHEREAS, the District will still have operators on "on-call" on November 28, 2014, December 26, 2014 and January 2, 2015 available to respond to emergencies; and

WHEREAS, the District has correspondence from the Service Employees International Union (SEIU) Local 620 in support of the District closure; and

**WHEREAS**, it is in the public interest to close the District for normal operating purposes, including the closure of the office, on November 28, 2014, December 26, 2014 and January 2, 2015.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** by the Board of Directors of the Oceano Community Services District, as follows:

- 1. That the District will be closed for normal operating purposes, including closure of the office, on November 28, 2014, December 26, 2014 and January 2, 2015.
- 2. District employees may take vacation time, paid time off other than sick leave and/or leave without pay on November 28, 2014, December 26, 2014 and January 2, 2015.
- 3. Standby operator(s) will be available for emergencies.
